Apex Companies, Inc., an independent third-party validator has provided limited assurance of our fiscal 2024 Scope 1 and 2 GHG emissions, which can be accessed on our website: https://https://impact.disney.com/app/uploads/2025/05/FY24-APEX-Limited-Verification-Statement.pdf Science Based Target initiative validated TWDC's goal to reduce absolute Scope 1 and Scope 2 GHG emissions by 46.2% by fiscal year 2030 from a fiscal year 2019 base year. TWDC has set a goal to achieve net zero emissions for scope 1 and 2 by 2030. Market-based emissions are used where available in calculating carbon credit retirements, total emissions, and net emissions. We define "net emissions" as follows: Scope 1 emissions + Scope 2 emissions (market-based) – carbon credits. Scope 2 emissions (market-based) include emission reductions attributed to utility green power purchases, power purchase agreements, and unbundled energy attribute certificates (EACs). We will have achieved our 2030 "net zero emissions" goal when "net emissions," as defined above, equals 0.
